## **Ngaahi tu'unga ki hono fakakakato fakafiemālie 'o ha koosi** **Criteria for satisfactory completion of a course**

Ke fakakakato fakafiemālie 'e ha toko taha ako ha koosii, 'oku fiema'u 'e he Poate ki he Akó (Board of Studies) (Board) 'a e puleakó ke 'i ai ha'ane fakamo'oni fe'unga kuo 'osi hanga 'e he toko taha akó 'o:
